 Answering the questions most often asked about the paranormal, this book provides tools for investigations into ESP, giving lists of research organizations, publications, and libraries, separating the serious resources from the sensational.

 An essay presented to the Department of Medicine of the University of Cambridge examining "psy functions" and how to address them from a psychotherapeutic approach in order to get them into a fuller perspective.

An exploration into what has been referred to as the "sixth sense," considered to be a window opening onto the real world of our inner consciousness. Bendit explains how this sense manifests and evaluates its usefulness to humanity.

A serious and complete outline of the subject, examining different levels of psychic abilities, their place in human evolution, the dangers and potentialities of methods usually advised to develop them, and the safe path towards an integral evolution of the inner man. T C785 MPD 1923 (Mini)

Duplessis, Yvonne, *The Paranormal Perception of Color*, c1975, 117 pages.

Applying methods of parapsychology, this book presents research from experiments on the appearance of color images in our mind without any direct stimulation of the corresponding sense.

Leadbeater, C. W., Clairvoyance, 1968, 226 pages.

The author, who was himself a highly developed clairvoyant, discusses this interesting subject explaining different kinds of clairvoyance as well as methods of development, pointing out dangers and those methods that can be safely recommended. **T L469 C**

Long, Max F., *Psychometric Analysis*, 1959, 118 pages.

Describing the psychometric analysis of people's features such as intelligence, health, and character, Long describes how to perform these readings by means of a pendulum, using personal objects, pictures, or signatures.

McCreery, Charles, *Science, Philosophy and ESP*, 1967, 199 pages.

Using an electroencephalograph to measure what is going on in the psychic's body, especially in the brain, generates scientific predictions about what findings should be expected. Phenomena like ESP and telekinesis are capable of being empirically tested. **133.07 McC SPE**

Radin, Dean I., *Entangled Minds: Extrasensory Experiences in a Quantum Reality*, c2006, 357 pages.

Based on scientific evidence the author shows that psychic phenomena such as telepathy, clairvoyance, and psychokinesis are real, as an unavoidable consequence of the interconnected, entangled physical reality we live in. **133.8 Rad EM**

Rhine, Joseph B., *The Reach of the Mind*, 1947, 234 pages.

The author, a pioneer of experimental investigation of "psi phenomena," reports the results of tests carried out at Duke University, postulating these phenomena as a challenge to materialist conceptions.

Rhine, Louisa E., *ESP in Life and Lab; Tracing Hidden Channels*, 1967, 275 pages.
A clear and readable account of all aspects of extrasensory perception and related abilities that gives a vivid picture of the research that established them in terms of both life experiences and laboratory experiments.

Ryzl, Milan, *Parapsychology; A Scientific Approach*, 1970, 216 pages.

Presenting evidence that psychic phenomena indeed exist, this scientist examines the whole range of them—clairvoyance, telepathy, precognition, etc.—describing the history, experiments and expected future of each area. **133.8 Ryz PSA**

Savage, Helen, *Psychic Powers*, 1948, 125 pages. A manual presenting a logical and philosophical explanation of the existence of psychic powers and paranormal activities—their nature, as well as their potential dangers—covering phenomena such as mediumship, hypnotism, and clairvoyance.

Sheldrake, Rupert, *The Sense of Being Stared At: And Other Aspects of the Extended Mind*, c2003, 369 pages.

Based on a database of 4,000 case histories, 2,000 questionnaires and 1,500 telephone interviews, the author explores the intricacies of the mind and phenomena like the power of attention, telepathy, remote viewing and premonitions.

Stoeber, Michael, Critical Reflections on the Paranormal, c1996, 224 pages.

A collection of essays discussing various aspects of paranormal phenomena such as telepathy, psychokinesis, trance-mediumship, near-death experiences and past-life memories. It reflects on what is reasonable to believe about them and why.

Wedgwood, James I., Varieties of Psychism, 1914, 109 pages.

Establishing the distinction between lower and higher psychism and classifying the various phases of it, Wedgwood explains their *modus operandi* and development as an evolutionary extension of our present faculties, acknowledging nothing supernatural about them. T W416 VP (Mini)

Walker, Claire G., *The Psychic Revolution of the 20th Century and Our Psychic Senses*, c1997, 166 pages.

A discussion of the existence and role of psychic sense as a direct inner knowing of a situation, distinguishing it from psychic power, and postulating that, though not necessarily spiritual, this sense will be important in humanity's evolutionary future. **133.8 Wal PR** Walker, Kenneth, *The Extra-Sensory Mind*, 1961, 256 pages.
Considering various psychological theories concerning the nature and function of the unconscious mind, the author contends that this portion of the psyche is responsible for so-called paranormal phenomena, such as ESP, apparitions, and precognition.

Philosophical essays by distinguished philosophers and scientists, presented in five sections, examine the relationship of psychic abilities with philosophy, cognition, precognition, survival after death, and science.
